Arrangements: Chun Wo Construction Holdings Company Limited (“Chun Wo”) should prepare a “Medical Treatment Authorization Form”, duly signed and stamped as a formal request to TY for the required medical services.

The injured should carry to our offices their Hong Kong ID Card (Passport for non-Hong Kong Citizens) as proof of identity.

Prior telephone appointment is always recommended to minimize waiting time.

Fee: HK\$470- per consultation will be charged to Chun Wo Construction Holdings Company Limited. This consultation fee will include a medical consultation by a general practitioner with up to 2 days of simple medications.

Extra Fees: Medical services apart from the basic services may incur extra fees,

Payment: The injured will not be asked for any payments in our medical centre.

Collective report of the injured will be given to Chun Wo Construction Holdings Company Limited. The payment should be settled within 60 days after the monthly invoice is emailed to Chun Wo Construction Holdings Company Limited. A 5% late charge will be applied for each or part of 30 days.

Report:

A medical report will be provided according to the employer's format. An email version of the report will be sent to the assigned personnel provided by Chun Wo Construction Holdings Company Limited.
